## JOCKEY CLUB – FACTS THAT SHOULD WORRY ALL OF US

1. The contract of “Companhia de Corridas de Cavalos de Macau, SARL” was recently renewed for few more months, following a previous renewal of two years.

All promised major improvement in the conditions of the equipment, almost all in rapid degradation (stables, sewage system, etc) and the new plans announced for the improvement of the Jockey Club activity worldwide didn't happen at all.

According to the last figures published in the Gazette and in the media, the company had accumulated losses of 4.073 billion patacas and negative net assets of 1.183 billion patacas.

The share capital of 3 billion patacas was fully “eaten” by its losses. This company is totally insolvent and bankrupted as the net assets are negative and the assets (mop 240.6 million) can not pay its accumulated debts (MOP 1.314 billion).

Besides that, by our Commercial Code (article 206), the Directors should dissolve it and if not should be fined or even subject to jail (article 485).

Jockey Club, just like Canidrome, are public property lands that should revert to the community for housing, green areas, underground car park, etc.

We hope a good decision is taken at the end of that concession next year.

2. Few days ago, Anima was informed that a serious case of cruelty has happened in Jockey Club, which is not by the way the first time cases of cruelty are reported. This time the information was disclosed in the Company news of the Jockey Club website.

Two horses were seriously neglected by a trainer Mr. K. M. Chin, that was considered guilty and was fined for negligence paying a penalty of HKD 40,000.00. The trainer has submitted an appeal!

According to our sources, this trainer has not provided enough food to two horses under his supervision (H001-Oyster Romance and H105-Lucky Rose) that are now dead. It seems one horse was imported from New Zealand and the other from UK!

## 澳門賽馬會 - 現實情況令人擔憂

1. 在較早時期“澳門賽馬會有限公司”之營運合約獲得續期兩年，最近有關合約獲得續期多幾個月。

當時，澳門賽馬會承諾會大大改善設施的狀態，它的設施幾乎全部快速地降級（馬房，排污系統等等）以及當時向外界公告的新發展計劃並沒有實踐。

根據最新在傳媒 Gazette 刊登的數字，澳門賽馬會累積虧損澳門幣 40 億元和負資產澳門幣 11 億元。

澳門幣 3 億元的股本也被其虧蝕完全吞食了。這公司已經資不抵債和破產，淨資產為負數，其資產澳門幣 2 億 4 千萬元也不夠支付累積債款澳門幣 13 億元。

除此之外，商法典中第 206 條指機構董事應該解決這問題，如不，應根據第 485 條被處罰或甚至入獄。

澳門賽馬會正如逸園賽狗場，同樣是在公共土地上營運。該土地應歸給社區作建房屋，綠化區，地下停車場等等。

我們期望在明年該營運到期時會有一個好的決定。

2. 幾日前，本協會收到通知在澳門賽馬會發生嚴重的殘酷對待事件。這已經不是第一次報導和發生的殘酷情況。這次事件在澳門賽馬會新聞網頁內也刊登了。

兩隻馬匹被練馬師 Mr. K. M. Chin 嚴重忽視，被判有罪和因忽視動物被罰款港幣 4 萬元。該練馬師提出上訴!

根據我們的消息，該練馬師在他的監管下沒有提供足夠食物給兩隻馬匹 (H001-Oyster Romance 和 H105-Lucky Rose) 導致死亡。一隻馬好像是來自新西蘭，另一隻好像是來自英國!

根據我們的消息，兩隻馬匹骨瘦如柴像戰時的囚犯!



## JOCKEY CLUB – FACTOS QUE DEVIAM PREOCUPAR-NOS

1. O contrato com a “Companhia de Corridas de Cavalos de Macau, SARL” foi recentemente renovado por alguns meses, no seguimento de anterior renovação por dois anos.

Todas as melhorias no recinto do Jockey Club prometidas no passado, nomeadamente em todo o equipamento e instalações (estábulos, sistema de esgotos, etc) e os novos planos anunciados para projectar a actividade do jockey Club a nível internacional nunca apareceram.

De acordo com os números publicados no Boletim Oficial e nos jornais, a empresa teve em 2016 prejuízos acumulados de 4,073 mil milhões de patacas e uma situação líquida negativa de 1,183 mil milhões de patacas.

O capital social de 3 mil milhões de patacas foi totalmente “comido” pelos prejuízos. A empresa, pelos dados do balanço, está totalmente insolvente e falida, pois a situação líquida é negativa e os activos (240,6 milhões de patacas) não são suficientes para pagar as dívidas que totalizam 1,314 mil milhões.

Por outro lado, não se cumpre o Código Comercial que preconiza que a Administração devia dissolver a sociedade (artigo 206), estando sujeita a multas e prisão (artigo 485).

O Jockey Club, tal como o Canidromo, estão em terrenos públicos que deveriam reverter para a comunidade para serem utilizados em habitação, áreas verdes, parques de estacionamento subterrâneos, etc.

Acreditamos que uma boa decisão irá ser tomada pelo Governo no próximo ano quando a concessão terminar.

2. Há alguns dias, a Anima foi informada de um caso sério de crueldade que aconteceu no Jockey Club e que não é caso único.

Desta vez a informação foi tornada pública pelo próprio Jockey Club no seu website.


As nossas fontes revelam que o treinador não teria alimentado suficientemente os animais sob a sua supervisão (H001-Oyster Romance and H105-Lucky Rose), animais que terão depois falecido. Segundo soubémos, um terá sido importado da Nova Zelândia e o outro do Reino Unido.

De acordo com as mesmas fontes, estes dois cavalos pareciam autênticos prisioneiros de guerra tal a sua magreza.

Esperamos que o Governo de Macau, através do IACM e da DICJ, puna severamente esse treinador, na medida em que acreditamos que a causa remota da morte desses animais teria sido tal negligência horrível, e proíba-o de voltar a exercer essa actividade no Jockey Club. Esperamos também que tal acto de crueldade e a punição que for aplicada pelo IACM seja devidamente publicitada pelo Governo de Macau, de modo a prevenir futuros casos de crueldade.

Finalmente, trata-se de mais um sinal de que o Jockey Club não controla a situação dos animais retirados das corridas, pois uma boa gestão não pode nunca detectar tal tipo de situações tão tarde!
